We, the representatives from the Government of Democratic Republic of Timor-Leste, the Development Partners, the Private Sector and Civil Society Organizations, met during the annual Timor-Leste Development Partners’ Meetings, in Dili on the 4th and 5th of July 2016 to discuss progress in achieving Sustainable Development.

Ami, representantes husi Governo, Parseirus Dezenvolvimentu, Setor Privadu, Organizasoens Siedade Sivil, hasoru malu iha Reuniaun Annual Timor-Leste ho Parseirus Dezenvolvimentu, iha Dili, iha lora 4 no 5 Jullu 2016 hodi diskuti progresu deszenvolvimentu sustentável.

We applaud the progress made in Timor-Leste in the past year since our last meeting. We congratulate the Government and its partners for their political commitment for and support to the Sustainable Development Goals (SDGs), and for the steps taken so far to start implementing the 2030 Agenda in Timor-Leste. We recognize the contribution of the Timor-Leste and the g7+ Group in securing the inclusion of Goal 16 on Peace, Justice and Institutions among the global SDGs. We support the Government of Timor-Leste’s intention to prioritize SDGs 2, 3, 4, 5, 6 and 9 next year.

We reaffirmed our desire to ensure our future efforts are aligned with Timor-Leste's Strategic Development Plan (SDP) and strengthen our partnership to support sustainable development in Timor-Leste in the future.

Recognizing the fact that financing for sustainable development will require resources from diverse sources for investment, we commit to coordinate and harmonize our actions and resources to finance sustainable development in Timor-Leste.

- Clearly provide leadership and coordination for sustainable development in Timor-Leste, including through regular coordination meetings in the priority sectors.
- Provide an enabling environment for private sector development.
- Localize the Agenda 2030 in line with the aspirational g7+ goals at the national and global level.

Ami, Governu Timor-Leste kompromete atu:

- Hatudu lideransa no koordensaun nebe klaru ba dezenvolvimentu sustentável iha Timor-Leste.
- Fornese ambiente ida nebe kondusivu ba desenvolvimento setór privadu.
- Lokaliza Ajenda 2030 tuir meta aspirasional g7+ iha nível nasional no global.

We, the private sector representatives, commit to inclusive business models in support of sustainable development. We commit to:

- Involve the local people in business processes as much as is possible, whether as producers, owners or consumers.

- Increase sustainability and responsibility in all our operations, whether we are dealing with the environment, tax, or human resources.
- Invest in partnership with the Government of Timor-Leste, working together to facilitate more and better investments and service provision in Timor-Leste.

- Involve ema lokal iha prosesu negósiu máximu possível, ba produtores, na'in no konsumidores.
- Hasa'e sustentabilidade no responsilidade iha operasaun hotu-hotu, wainhira ita liga ho ambiente, impostu, no rekursu umanus.
- Investe iha parseria ho Governu Timor-Leste, servisu hamutuk hodi fasilita investimentu nebe diak liu no prestasaun servisu iha Timor-Leste.

We, the development partners, commit to :

- Support long-term approaches towards sustainable development in Timor-Leste by strengthening the use of country systems; provide timely and predictable aid in line with the New Deal Principles; and mobilize resources to support the Government's Strategic Development Plan (SDP) and to support the Government's efforts in achieving the SDGs.

- Suporta aproximasaun ba dezentvolvimentu sustentável iha Timor-Leste hodi hametin uza Sistema Paíz nian; fornese assisténsia esterna nebe previsível no atempada tuir prinsipiu New Deal (Akordu Foun) ; no mobiliza rekursus hodi suporta PED Governu nian.

We, the civil society representatives, constructively engage with the Government in working towards the achievement of sustainable development. We commit to:

- Add our expertise and resources to national efforts to achieve sustainable development, and ensure accountability and fairness for sustainable development implementation.

design a new Aid Policy of RDTL aiming to improve aid effectiveness. We conclude our meeting with deep appreciation for the organisation on the part of the Government of Timor-Leste.
