7. The bids must be received in the Tender Box located at **National Procurement Commission Office, Rua de Balide, Dili, Timor-Leste** no later than **15:00 PM local time 07 September 2017**. Late bids will not be accepted and will be returned un-opened to the bidder.
8. Bids must accompanied by a **bid security** in amount specified in notice and bidding documents.
